1. CONTENT OF THE RULES OF PARTICIPATION

The following contents state the Rules of Participation for the Training Course “Storytelling, video and theatre when working with migrant and second generation youth” within the project IntegrART organized by **ISTISSS - Istituto per gli Studi sui Servizi Sociali** (Italy), as promoter, with the partnership of **Fundacion Escuela de Solidaridad** (Spain), **The Society of Orestes** (Greece), **Stichting Diversiteitsland** (The Netherlands). The project is promoted by Italian National Agency in the frame of Youth in Action Programme.

2. RULES OF PARTICIPATION

- All participants are requested to fill the forms for the evaluation of satisfaction at the end of the training course, and once back home, they are requested to fill the forms follow up evaluation.

Reimbursement:

- After the confirm of the participation, participants are invited to buy on line ticket, but only with previous authorization of the project's promoter (ISTISSS). The participants are requested to fill the travel reimbursement claim attached and send it to ISTISSS at the following email address (**inserire indirizzo e mail**)
- All participants are requested to conserve the original invoices for the tickets and to send them as soon as possible (first scanned copy and then the original by post) in order to get the reimbursement.
- Participants will receive 70% refund of their travel costs (included transfer from airport and public transportation). The transportation cost are refundable for the 70% up to 250.00 €, on the basis of the original ticket and invoices.
- Italian participants will receive the reimbursement of the local transportation.

Facilities and safety:

- All accommodation and food costs will be covered by the organizers part (except accommodation cost for italian participants). Extra food, and extra drink beyond the ones provided will be at own expense of the participants.
- Participants are requested to respect the rules of behavior stated by the hotel.
- The participants are responsible for the safety of his/ her belongings.
- Any damage/breakage to hotel property or to any material provided for the project will be charged to the responsible.
